Privacy Policy

We respect the privacy of each individual and we will be committed to protecting the personal information that is provided to us. This Privacy Policy will outline and explain how Schoolling will use the information collected from anyone who chooses to use our services. We reserve the right to make changes to our policy as we see fit, without the obligation to inform any individual.

SECTION 1 – INFORMATION

What we collect: We collect a few general types of information when one visits our Site, namely:

- Personal Information – the information that may be used to identify an individual i.e. Name, mailing address, telephone number, other info that can be used for identification and/or any information regarding third parties.
- Demographic Information – information not unique to an individual or that refers to selected group characteristics i.e. ZIP Code/postal code, age, preferences, gender, race/ethnicity, occupation, interests and/or favorites.
- Behavioral Information – information about how an individual uses our Site. It includes the areas of the Site visited, services accessed, information about computer hardware and software including the IP address, browser and operating system, access times, domain names, and referring web site addresses.

Use of information: We gather the above-mentioned information for the following purposes:

- To ensure that we provide seamless services such as communications, promotions and any other information that may be of interest to you.
- To provide information and to respond to any queries that one might have.
- To improve and operate the Site and application for positive user experience.
- To comply with laws, and;
- To prevent, investigate, or take action regarding illegal activities, suspecting fraud, potential threats to the physical safety of any person, violations of Schoolling's Terms of service agreement, or as required by law.

SECTION 2 – CONSENT

When one provides us with personal information to complete a transaction, verify your card or place an order, we imply that you consent to our collecting it and using it for that purpose only.

SECTION 3 – DISCLOSURE

We may disclose personal information if we are required by the law to do so or if one violates our Terms of Service.

SECTION 4 – PAYMENT

We use PayUMoney for processing payments. We/ PayUMoney do not store ones card data on their servers. The data is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS) when processing payment. Ones purchase transaction data is only used as long as it is necessary to complete the purchase transaction. After that is complete, ones purchase transaction information is not saved.

Our payment gateway adheres to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover.
